#### WAYNE TOWNSHIP ROAD DISTRICT

#### TAX LEVY ORDINANCE

An ordinance levying taxes for all road purposes for the Wayne Township Road

District, DuPage County, Illinois, for the year 2016.

BE IT ORDAINED by the Board of Trustees of Wayne Township, DuPage County,

Illinois, as follows:

\$1,488,034.00

SECTION 1: That the Highway Commissioner of Wayne Township Road District does hereby determine and declare the sum of <u>One Million Four Hundred Eighty Eight Thousand Thirty Four Dollars</u> are hereby levied upon all property subject to taxation within the road district as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the road district as required by statute or voted by the people in accordance with the law, for such purposes as:

Road and Bridge

Social Security

Permanent Hard Road

Illinois Municipal Retirement

Equipment and Building

Tort Liability/Insurance Fund

for the year 2016.
