TAX LEVY ORDINANCE

An ordinance levying taxes for all town purposes for Wayne Township, DuPage County, Illinois for the tax year 2016, collectable in 2017

BE IT ORDAINED by the Board of Trustees of Wayne Township, DuPage County, Illinois, as follows:

\$1,875,775

SECTION 1: That the sum of <u>\$ One Million Eight Hundred Seventy Five Thousand Seven Hundred Seventy Five Dollars</u> are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:

 Town Social Security Fund

 General Assistance
 Town IMRF Fund

Town Tort/Liability Fund Special Police

Town Audit Fund

for the year 2016.
