# **MEETING**

Presiding Officer Feltes asked Anna Pechous to discuss the proposed Town 2018-2019 levy worksheet. The CPI is 2.1% for 2018. She and Supervisor Ramey are proposing a 3.5% tax levy to cover the costs of the \$1.5 million loan. Trustee Brinkman asked for justification on the proposed increase. Anna responded it is due to the building remodeling project's increase in space that will increase upkeep and maintenance costs. The difference between levying 2.1% and 3.5% is \$24,580 in tax dollars captured. \$1.1 million is remaining to pay off the loan. Trustee Brinkman asked about the \$400,000 cushion that we should have from paying off the original loan. Anna explained that the Township has \$22,000 remaining on the loan for the lights, upcoming parking lot costs and costs associated with the cemetery. Anna explained if the Board levies flat the County gives the Township the same amount of tax dollars it received last year.
