General Assistance has been consistent with the amount of people attending the weekly distributions. The new truck has been very useful for picking up donations. The Northern Illinois Food Bank unfortunately stopped the CFAP Program. Work is still be completed on the CARES Act Intergovernmental Agreement with DuPage County. SWAP has been out spreading mulch and cleaning up the township. They are scheduled to come back the third week in September.
