TAX LEVY ORDINANCE

An ordinance levying taxes for all town purposes for Wayne Township, DuPage County, Illinois for the tax year 2020, collectable in 2021

BE IT ORDAINED by the Board of Trustees of Wayne Township, DuPage County, Illinois, as follows:

\$2,038,287.00

SECTION 1: That the sum of \$ **Two Million Thirty Eight Thousand, Two Hundred Eighty Seven Dollars** are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:

Town Social Security Fund

General Assistance Fund

Town IMRF Fund

Town Tort/Liability Fund

Special Police

Town Audit Fund

SECTION 2: That the amount levied for each object and purpose shall be as follows:


