TAX LEVY ORDINANCE

An ordinance levying taxes for all town purposes for Wayne Township, DuPage County, Illinois for the tax year 2017, collectable in 2018

BE IT ORDAINED by the Board of Trustees of Wayne Township, DuPage County, Illinois, as follows:

\$1,896,399

SECTION 1: That the sum of <u>Hundred Ninety Six Thousand Three</u> are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:

Town FundTown Social Security FundGeneral Assistance FundTown IMRF FundTown Tort/Liability FundSpecial PoliceTown Audit Fund

for the year 2017.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
