Hoping the CARES Act funding will help assist with the funding needs.

# E. <u>Resolution 2020-11-05 Setting Compensation of Township Officials for the Four Year Term Beginning May 17, 2020</u>

SUPERVISOR - Supervisor Ramey recommended the position of Supervisor be paid \$45,000 annually plus \$1,000 annually for the role of Road District Treasurer. IMRF will be paid if the Supervisor qualifies by working 1,000 hours or more per year. Health, dental, and life insurance will not be paid to the Supervisor.

Trustee Brinkman moved to approve the Supervisor's salary of \$45,000 annually, \$1,000 annually for the role of Road District Treasurer and IMRF if more than 1,000 hours are worked annually.
